



Next Steps for IIC & oneM2M

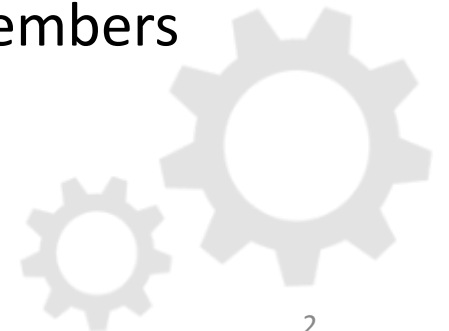

Outcome

- IIC and oneM2M already got in touch in the past via activities of common members
 - InterDigital & Huawei OHTP effort
- Formally established a liaison relationship in 2017
- For the first time took a bit more detailed dive to enable better understanding among the respective membership of what each organization is doing
- Had very useful discussions throughout this week and in particular during the workshop
- Need to identify the next steps that are needed to create value to members





Short term actions to take (1)

- Initiate drafting of a joint White Paper on Architecture Mapping
 - Enable members & market to understand oneM2M could be a tool to implement important IIC concepts and show how this fits into the IIRA
- Arrange for more joint Workshops between the two organizations
 - Need for clarifying details on oneM2M and how to implement IIC concepts
- IIC Officials & Members to attend oneM2M TP Industry Days
 - Meant to get feedback from industry and educate about what oneM2M is
 - Opportunity for IIC Officials to present on specific topics

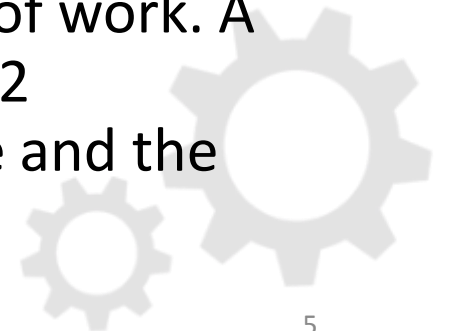




Longer term actions to take

- IIC to explore and consider joining oneM2M as a Partner Type 2 **
- oneM2M to explore and consider joining IIC as a Member
 - Note that one of the Partner Type 1 organizations (those who founded oneM2M and transpose its output to regional standards) is already a member of IIC: TTA of Korea is a member of IIC already
 - TTA may act as a proxy for the other Partner Type 1 organizations

** A Partner Type 2 is any legal entity which is member based and has acknowledged competency in developing standards in oneM2M's area of work. A Partner Type 2 provides strategic direction to oneM2M. A Partner Type 2 can attend, participate in and vote in the oneM2M Steering Committee and the oneM2M Technical Plenary and its subgroups.
